TAPS 2014

The Division's three day, multi-track CLE seminar, Texas Advanced Paralegal Seminar, TAPS 2014: The Beat Goes On! was held in Austin October 1 through October 3. It was a big success with over 260 paralegals attending. The PD enjoyed tremendous vendors' and exhibitors' support, with many door prizes given to attendees. And for the first time, the PD rolled out its new TAPS app which allowed attendees to keep track of the event schedule, to include CLE sessions, socials, and a directory of attendees. The app also included the Click game, a photo scavenger hunt which allowed attendees to engage one another. The event was capped with the Friday attendees luncheon with keynote speaker, Thomas Watkins on *Dance with the One who Brung You*, an insightful presentation on the paralegal profession. The first two players of the app Click game to correctly submit their photos for points won a prize. The TAPS 2014 Scholarship winners, Olga Burkett (El Paso) and Christianna Yarbrough (Fort Worth) were recognized. To end the luncheon the names of the four lucky grand prize winners of \$500 a cash prize were drawn, specifically Patricia Simecek (Temple), Susan Davis (Fort Worth), Penny Keller (Austin) and Robin Swattes (Houston).

The Division's salary survey of all Texas paralegals regardless of member status was conducted August 1, 2014, through September 15, 2014.

Winter Board of Directors Meeting

After District 13 was dismantled and its members integrated into District 1, President Buckland felt that District 1 had grown exponentially and questioned whether all the members in that district would be represented. After discussing the matter with District 1 Director Cook, the matter was placed on the agenda, and the board voted to create an additional seat within District 1. Per the standing rules, it was announced that the two District 1 directorships, Seat One and Seat Two would be filled during the election to be held at the same time as elections of Directors in odd numbered districts for the following fiscal year.

SBOT Executives - PD Members. MCLE Efforts

President Buckland continued to work on the PD's efforts that the SBOT MCLE Rules and Regulations be revised to allow teaching credit to attorneys who present substantive continuing legal education to paralegals. Ms. Tina Green, SBOT Board Member and Board Advisor to the Paralegal Division, directed President Buckland to submit the PD's position on the matter to Trey Bergman, Chair of the Ad Hoc Committee looking into this request. On January 14, President Buckland wrote Mr. Bergman, and in response, was invited to attend the MCLE Committee meeting to present the request personally and answer any questions of the committee members. President Buckland attended the February 5 meeting. At the conclusion, the committee said they wanted a PD member to serve on the SBOT's MCLE Ad Hoc Committee. In the Spring of 2015, SBOT President DuBois appointed Susan Wilen, RN of San Antonio, to the MCLE Committee as a public member.

TAPA 2015
