TAPS 2018 was held in Addison, Texas at the Crowne Plaza Dallas Near Galleria, on September 26-28, 2018. The theme was "*Just in Time for CLE – The Magic of TAPS 2018*". This year's charity was the Chris Kyle Frog Foundation. The three-day seminar had 65 speakers who spoke on various areas of law to 194 TAPS attendees which provided a total of 14 hours of CLE. The keynote speaker at the Friday luncheon was Terry Bentley Hill speaking on "Hope and Healing and a Few More Gifts Along the Way." The total amount collected for the Chris Kyle Frog Foundation was \$1,807.50.

2018 Fall Board Meeting
