**Certified Paralegal, CP and Advanced Certified Paralegal with NALA**

- 50 Hours of CLE, including 5 hours of legal ethics every 5 years

**TBLS-BCP**

- 30 Hours of CLE in the specialty area within the 3 years immediately preceding application, through December 31st in the year of the application (COULD BE AN ADDITION TO THE LETTER FOR THOSE WHO ARE PLANNING ON TAKING THE TBLS EXAM THIS YEAR/NEXT YEAR/FUTURE)
- 75 Hours of CLE in the specialty area by December 31st of each 5th year of certification

Additionally, I am an Active member of the Paralegal Divisions of the State Bar of Texas. As such, I am required to complete 5 hours of CLE and 1 hour of Ethics by May 31, 2025 to renew my membership.
